
# THE NATIONAL RIVERS AUTHORITY



# THE LOWER BRISTOL AVON CATCHMENT MANAGEMENT PLAN

We want to involve you in planning a future for the lower reaches of the River Avon.

We have just published our Consultation Report for public comment. The report details our ideas for improving the Lower Bristol Avon. This leaflet explains why we have published this Report; why your views are important and where you can find a copy of the Report.

The Consultation Report describes the area and explains what environmental qualities we are trying to protect or improve. For example it identifies pollution problems; threats to water resources from quarrying in the Mendip Hills and how development puts pressure on the catchment. We also discuss how farming practices affect the water environment.

## WHY DO WE NEED PLANS FOR OUR RIVERS?



Rivers can offer peaceful open spaces in our cities

People use and appreciate rivers in different ways, for example:

 we might use a river to dispose of our treated waste

the Water Supply Companies might take water from rivers or from underground for our household supply or

an angler might enjoy some peaceful fishing on the riverbank.

It is our job to try and balance these, and many other needs and at the same time try to

improve the water environment now and for the future. We use a process known as Catchment Management Planning to help us achieve this. The Consultation Report is the first step in this process.

### THE CATCHMENT

The Lower Bristol Avon Catchment includes the River Avon and all its tributaries downstream of Bradford-on-Avon. Most of the catchment lies within the county of Avon with small areas in Wiltshire and Somerset. The area includes the cities of Bath and Bristol whose prosperity has been closely linked with the river. Today water is an important feature in these cities and a valuable natural asset for Planners to protect and restore as they shape the future development of the catchment.
